1. Scope

This Privacy Policy explains what personal data MealMaster processes, why we process it, and what rights users have.

By using MealMaster, you acknowledge this Policy and agree to processing required to provide the service.

2. Data We Process

Depending on your usage, we may process the following categories of data:

- Account data: email address, profile name (if provided).
- Nutrition profile data: date of birth, height, weight, sex, activity level, nutrition goal, and calculated calorie/macronutrient targets.
- User content: avatar image and screenshots attached to feedback reports.
- Technical and analytics data: app usage events, diagnostics and crash logs, and technical identifiers required for Firebase services.

3. Purposes of Processing

We process personal data to:

- Create and maintain user accounts.
- Calculate personalized nutrition targets and generate meal plans.
- Sync user data across devices.
- Handle support requests and product feedback.
- Improve app reliability, quality, and security.

4. Legal Bases

Our legal bases include:

- Performance of a contract: to provide app functionality requested by the user.
- User consent: for optional actions such as sending support content.
- Legitimate interests: service security, fraud prevention, and product improvement.

5. Third-Party Processors

MealMaster uses third-party infrastructure providers, including Google Firebase:

- Firebase Authentication
- Firebase Analytics
- Firebase Crashlytics

6. International Transfers

Because cloud services are used, data may be processed outside the country of residence of the user.

We apply reasonable safeguards for international data transfers.

7. Retention

We keep data only as long as needed for the purposes described in this Policy, unless a longer period is required by applicable law.

If you delete your account, related data is removed according to our deletion process and legal obligations.

8. Security

We use organizational and technical measures designed to protect data against unauthorized access, alteration, disclosure, or destruction.

9. Your Rights

Subject to applicable law, you may request to:

- Access your personal data.
- Correct inaccurate data.
- Delete your data and account.
- Withdraw consent where processing is based on consent.

10. Account and Data Deletion

You can request deletion from within the app (Profile -> Delete account) or via the public instruction page:
